child abuse, molestation and abduction of our children. It is a national educational system that teaches and informs children and parents about "Danger Awareness"

provides families with resources that can help expeditiously disseminate information about abducted or lost children.

Kid-Safe Communities has recruited and trained a National Staff and a network of Advocates who work at providing both education and practical self-defense techniques to help women and children avoid and defend themselves during dangerous situations.

Thousands of young boys and girls are assaulted, sexually abused or abducted each year and we must work harder to reduce this number and increase the number of pedophiles that are arrested and put in jail.

## What We Do

Kid-Safe Communities is working diligently with Local and State Police Agencies and the FBI to help identify and apprehend these pedophiles. Field Agents of the Kid-Safe Communities are asked to:

- Collect and disseminate information about lost and missing children.
- Assist local law enforcement agencies in your area with pro-active education.
- Act as a liaison between the Kid-Safe Communities and their neighborhood.

#### **Educational Workshops**

Kid-Safe Advocates provide several educational workshops to inform the public on the lures and tactics of predators, safety at home and on the Internet, danger awareness, practical self-defense techniques, and related safety tips.

Workshops can be tailored to parents or children, and are presented in a manner designed to inform, not to create fear or anxiety. Content is designed to be age-appropriate, depending on the venue.

Self-defense workshops present practical ways for children to learn how to respond to predator advances using effective countermeasures.

## **Scheduling An Event**

Kid-Safe Advocates are available to speak to school groups, PTA's, church, civic or community groups upon request. Most workshops last 45 minutes to one hour in length. There is NO COST for a Kid-Safe educational workshop.

There are four basic Kid-Safe workshops:

- 1. Profile of a Predator & Home Safety
- 2. Predator Lures and Defensive Countermeasures
- 3. Molestation, Abuse & Internet Safety
- 4. Fire Safety, Lost Child, Safety at Home

We also provide access to Child Identification Kits, Fingerprint Kits, Online Child Profiles, and educational DVD's to help supplement the safety information provided during our workshops.
